Section 1-Selling Commission

 - 2. Calves & Yearlings \$23.00/hd
 - 3. Weigh Cows & Heiferettes 2% of gross sale
 - 4. Butcher Bulls up to 1200# 2% of gross sale
 - 5. Butcher Bulls over 1200# 2% of gross sale
 - 6. Breeding Bulls by the head 2% of gross sale
 - 7. Stock Cows by the head 2% of gross sale
 - 8. Stock Cows with calves tagged to match 2% of gross sale

Section 2-Yardage (Yardage covers SALE DAY feed with the exception of bred stock and pairs)

Section 3-Feed

ALL Livestock

This is subject to change based on the current market value of hay and delivery cost of hay.

A. Extra feed fed before or after sale if charge applies.

- 1. \$3.00/calves, yearlings
- 2. \$4.00/cows, heiferettes & bulls if charges apply.
- 3. \$5.00/head per day on bred cows & pairs including sale day if charges apply.
- 4. \$6.00/head per day on all stock going to slaughter starting at noon on the following day of the sale and \$7/head per day after 7 days.

Section 5-Veterinary Services

- A. The schedule of charges on all necessary veterinary services performed by an accredited veterinarian will be at the posted uniform per head rates, pursuant to company agreements with the veterinarian performing such services and does not contain any charges retained by market.

Section 6-Other Charges & Fees

- A. Check off money will be collected as stated by Federal and State law.
- B. The schedule of charges on brand inspection, as authorized by the Nebraska Brand Commission will be posted by the Brand Inspector, and does not include any charges retained by the market.

Section 7-Resales & No Sales

- B. Resales-Resale charges shall apply on all livestock resold without leaving the company livestock market premises.

Section 8-Credit Card Usage

- A. The Market will charge 3.75% on all credit card purchases.

Section 9-Dead and Tallow Fee

- A. \$150 per head for each animal dead for disposal fee.
